Chapter Zero Romania stakeholders

Members are non-executive and executive directors who share examples of good practice, participate or speak at events, refer other non-executives to the network and provide feedback to the chapter. Chapter Zero Romania can offer members access to practical tools and guidebooks which enable Board directors to have informed conversations on the climate agenda

Board of Directors & Patron Chairs: Provides governance and direction to the chapter. They are responsible for setting the strategy and meet once per month, or whenever necessary

Partners support the development and activities of Chapter Zero Romania and could be:

- Influencers act as levers to promote climate awareness and competence on boards through their own areas of influence/expertise, by creating methodology, thought leadership pieces and hosting events for the chapter. They include board evaluators and recruiters, remuneration consultants, general counsel and company secretaries, ratings agencies and proxy advisers and asset owners and asset managers.
- **Collaborators** are leading companies, climate experts and other bodies that actively provide climate change insight and education for members. The chapter provides support to the collaborators to adapt the content for the non-executive directors audience and invites its members.
